With Trestle, Technology Providers such as yourself can subscribe to Trestle, undertake the simple configuration required to use the service, and begin making connections to license listing content from Multiple Listing Organizations.

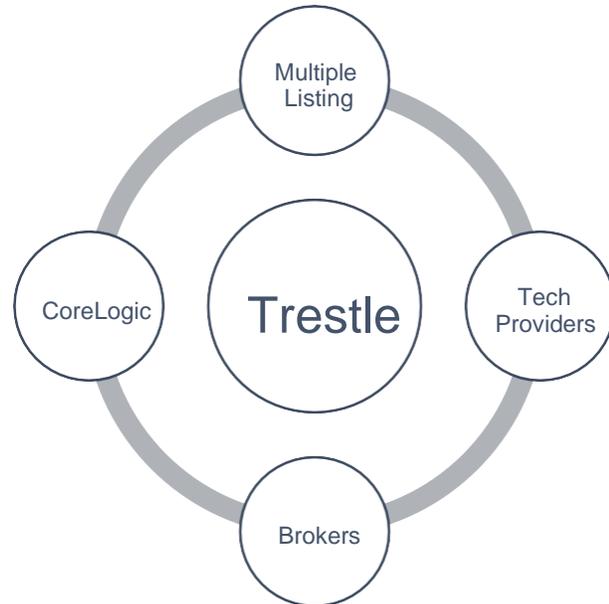

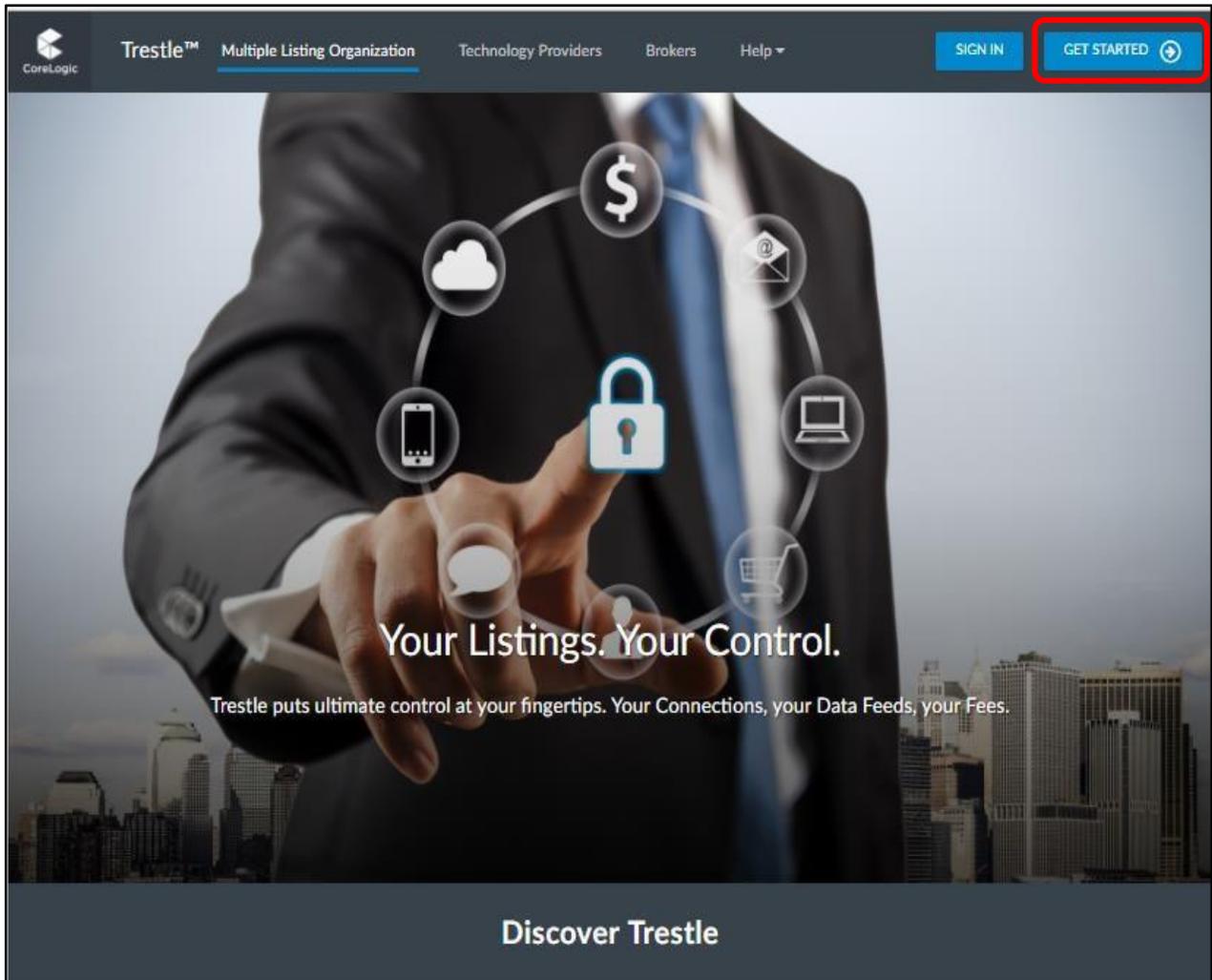


Trestle Subscriptions

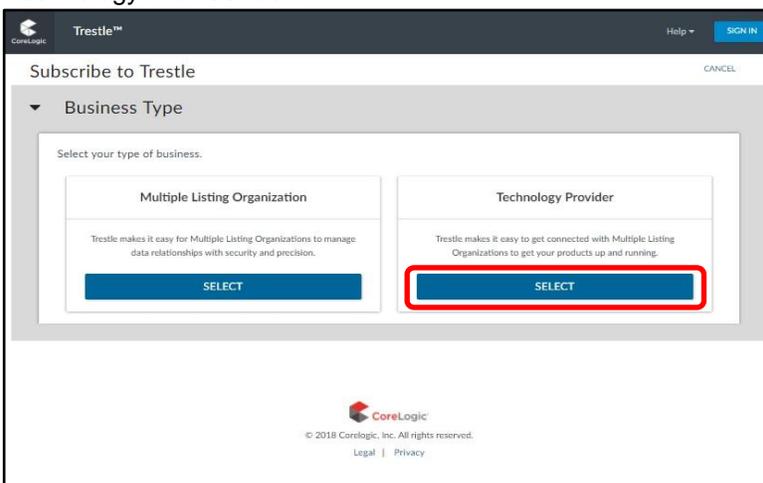
Your organization must subscribe to Trestle to undertake configuration and commence making Connections to license listing data. Trestle subscriptions are month to month, and there is no cost until one or more Connections to license data are approved. Trestle service fees can be accessed [here](#).

Please follow the instructions below to subscribe to Trestle. Before you begin, please review the instructions to ensure you have gathered all the information required to successfully complete the process.

- Go to <https://trestle.corelogic.com/> and click on "Get Started".



- Select your business type as “Technology Provider”. To continue, click the **Select** button appearing inside the Technology Provider box.



- Enter your **Primary Contact Information**. As the person completing the subscription forms, you are probably the Primary Contact who will be responsible for general administration of your organization's Trestle account.

PLEASE NOTE: The Primary Contact must be someone from your organization who has the authority to approve the Trestle subscription agreement on behalf of your company. If that is not you, please be prepared to provide that person's contact information instead.

To enhance security, a strong password is required. Note that your password must contain at least one uppercase letter, one lowercase letter, one number, and one special character (such as # or @).

When you have entered all the required Primary Contact Information, click Next.

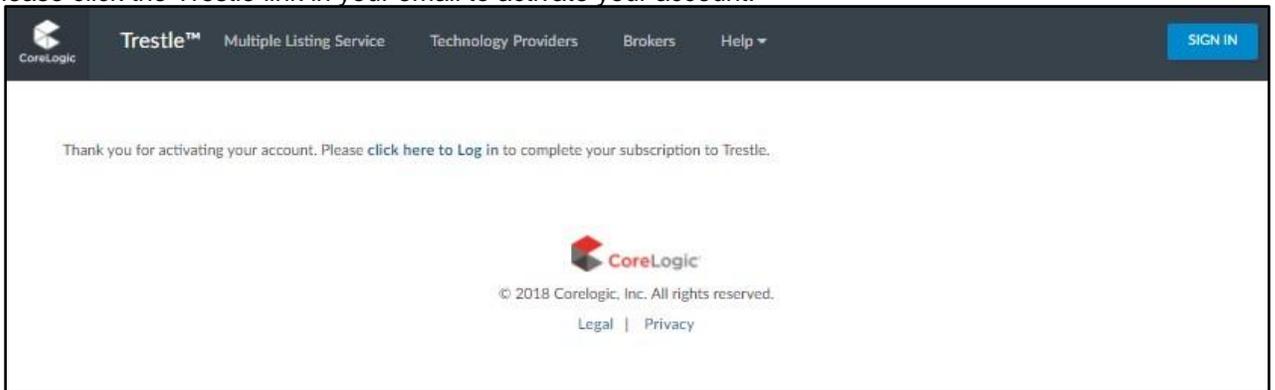

1. DEFINITIONS

1.1 "Confidential Information" means, without limitation, the Services, the terms and conditions (but not the existence) of this Agreement, and all information relating to the business of the disclosing party ("Disclosing Party") which the receiving party ("Receiving Party") ought reasonably to consider to be confidential and all information identified by the Disclosing Party to the Receiving Party as proprietary or confidential. Confidential Information may be written or verbal.

1.2 "CoreLogic Data" means certain data (excluding Data Feeds of multiple listing data) provided by CoreLogic through Trestle (if applicable).

1.3 "CoreLogic Data Addendum" means an addendum which reflects the terms pursuant to which Subscriber may access and use CoreLogic Data (if applicable).

1.4 "CoreLogic Data Fees" means the fees payable by Subscriber to CoreLogic for access to CoreLogic Data (if applicable).

1.5 "CoreLogic Fees" means CoreLogic Data Fees and/or CoreLogic Platform Fees.

1.6 "CoreLogic Platform Fees" means the fees payable by Subscriber to CoreLogic for access to Trestle.

1.7 "Data Feed" means a feed of multiple listing data delivered to Subscriber by a Multiple Listing Organization

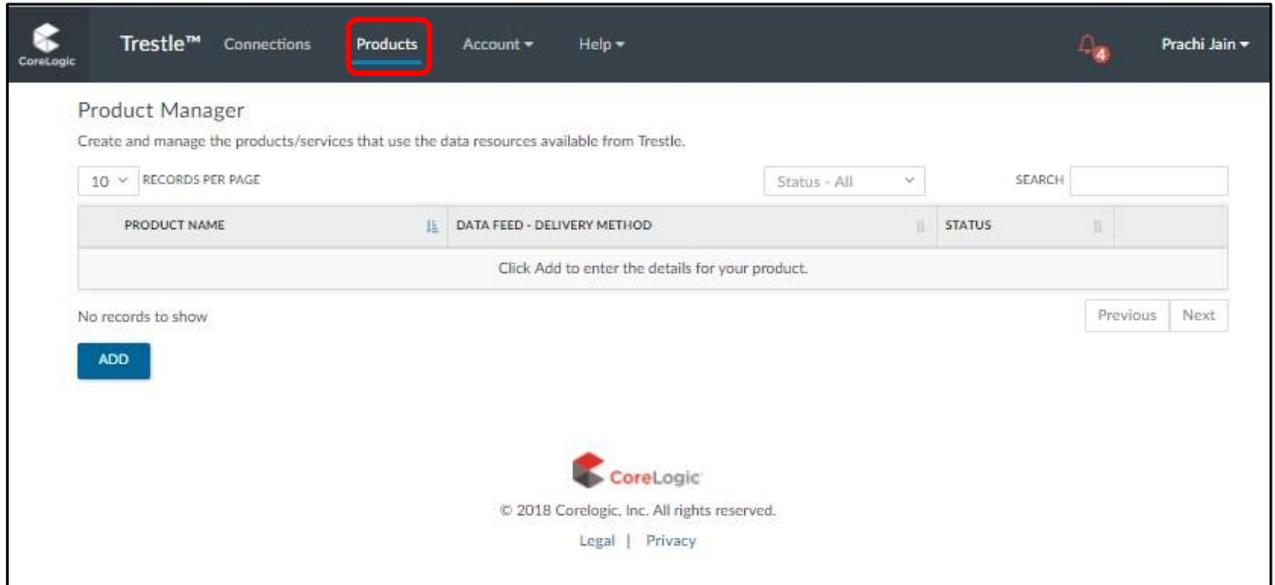

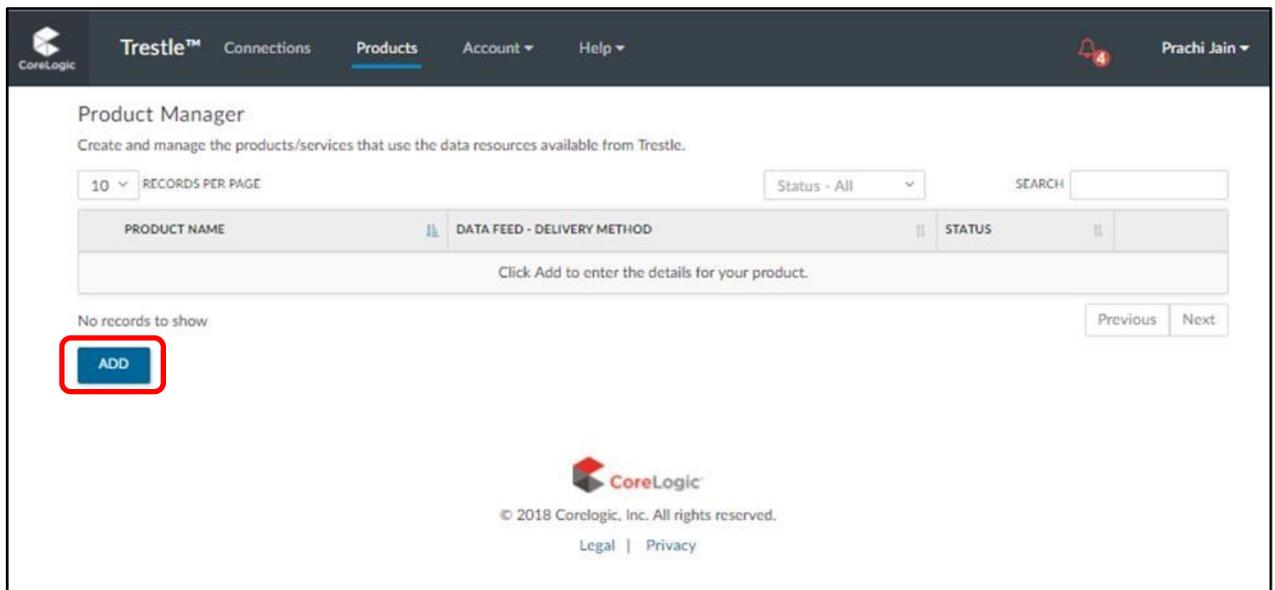
Product Manager

The Product Manager enables you to enter one or more products for which you may seek to license listing content via Trestle. To make Connections via Trestle and ultimately license listing content from a multiple listing organization, you must enter at least one product.

- Click on the “Products” tab in the top navigation .



- To add your first product, please click Add. Entering a product has two distinct tasks:
 - ✦ Enter Product Information
 - ✦ Enter Data Feed Information



Product Information

Enter the following product information:

- **Product Name**
- **Product URL/Location** with which actual services are associated > **Product Description**
 - ✦ The product description is important as it's visible to Trestle subscribers who wish to learn more about your solution. Consider it free marketing!
 - ✦ When you initiate a Connection with a Multiple Listing Organization, the product description is automatically inserted into the data license agreement generated by Trestle. A deficient description could cause a multiple listing organization to decline your connection if it believes the product use and audience are inadequately explained.
- **Product Type** indicating if your product is a Web, Desktop or Mobile solution
- **Product Status** indicating whether the product is In Development or In Production
- **NOTE:** Product Active field is automatically updated by Trestle; it appears for informational purposes only.

When the product information has been entered, you may click “**Add RESO Data Feed**” or “**Add RETS Data Feed**” to associate one or more data feeds to the product. Clicking **Add** automatically saves the product information you already entered. However, if you choose to add a data feed later and do not click **Add**, please be sure to click **Save**.

Lastly, Multiple Listing Organizations typically require a separate data license for each product using their listing content. As a result, Trestle does not permit a single Connection to cover multiple products.

Data Feed Information

Trestle currently supports the following data feeds:

➤ RESO Compliant Data Feeds

- ✦ IDX via RETS and/or API
- ✦ IDX Plus via RETS and/or API
- ✦ VOW via RETS and/or API
- ✦ Statistics via RETS and/or API
- ✦ **NOTE** - IDX includes solely active listings and the related, relevant fields. IDX Plus is distinguished from IDX simply by the availability of sold listings and the addition of related fields.

○ Matrix Native RETS Data Feeds

- ✦ IDX and IDX Plus via RETS
- ✦ Listing data via API with Trestle Direct
- ✦ **NOTE** – These feeds allow a Technology Provider to request a data feed directly to the Matrix server.

While Data Feeds such as IDX and IDX Plus are delivered in a unified and consistent manner across all multiple listing organizations, please recognize that individual multiple listing organizations may further refine their own Data Feeds via Trestle by suppressing access to certain fields.

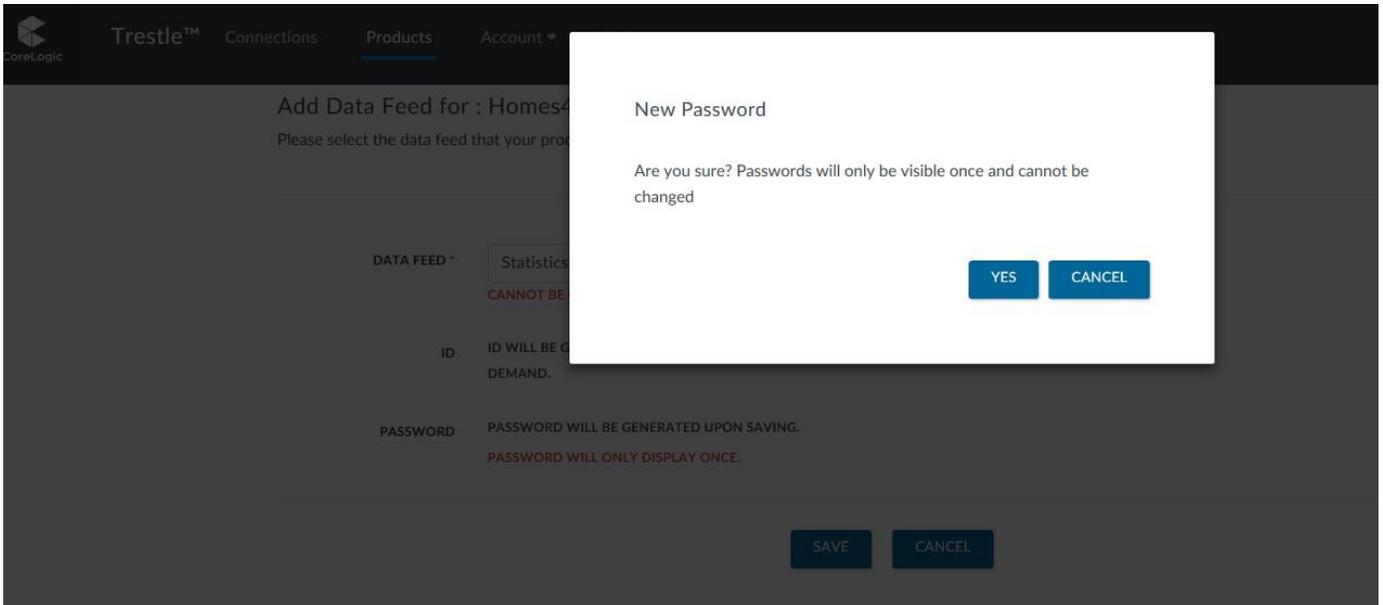
Add RESO Data Feed

After clicking “Add RESO Data Feed”, select the feed you would like to connect to. Both the feed ID and feed password will be assigned upon creation.

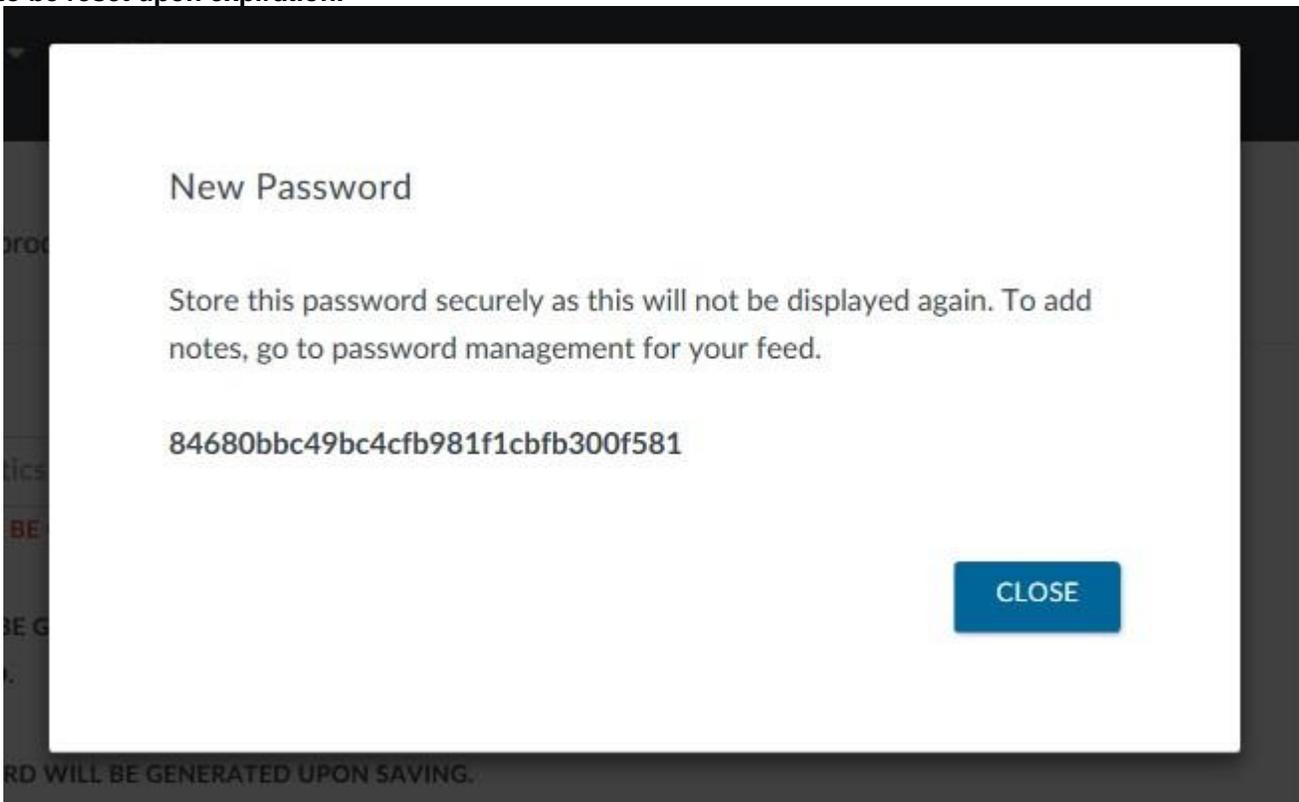
- Select a Data Feed from the drop-down list
- Click Save button
- You will be prompted confirm and be reminded passwords will not be visible or retrievable after feed creation

Once a feed has been associated, an additional password and other functions can be added from the credential manager, found within the product manager.

Credential Manager

Navigate to product manager > scroll down to feed you'd like to manage or review > select manage > from there make changes and additions as needed.

Within the Credential Manager a user can:

- Review the credential id associated with a product/feed combination
- Add notes per credential
- View creation and expiration date
- Reset or Delete a password
- Add additional credentials (maximum of two per product/feed combination)

**DATA ACCESS AGREEMENT
(TRESTLE)**

This Data Access Agreement (“Agreement”) is entered into between *****Austin MLS (SAMPLE DATA)***** (“Multiple Listing Organization”), a(n) North Carolina corporation or company, and XYZ (“Technology Provider”), a(n) California corporation or company, and is effective as of the date of the last signature below (“Effective Date”).

The parties agree as follows:

1. DEFINITIONS

1.1 “Authorized Broker” means a Participant identified in any Broker Authorization Form between said Participant and Multiple Listing Organization.

1.2 “Broker Authorization Form” means the separate form by which Multiple Listing Organization authorizes Technology Provider to provide the Product to a specified Authorized Broker. For the avoidance of doubt, (i) a Broker Authorization Form may be entered into on and/or after the Effective Date of this Agreement, and (ii) there may be multiple Broker Authorization Forms throughout the course of this Agreement.

1.3 “Listing Data” means the multiple listing data specified in Exhibit A.

1.4 “Participant” means a participant of Multiple Listing Organization, as defined in the Policies.

1.5 “Policies” means the Rules and Regulations and any operating policies of Multiple Listing Organization, as may be amended from time to time.

1.6 “Product” means Technology Provider’s product or service identified at Exhibit A.

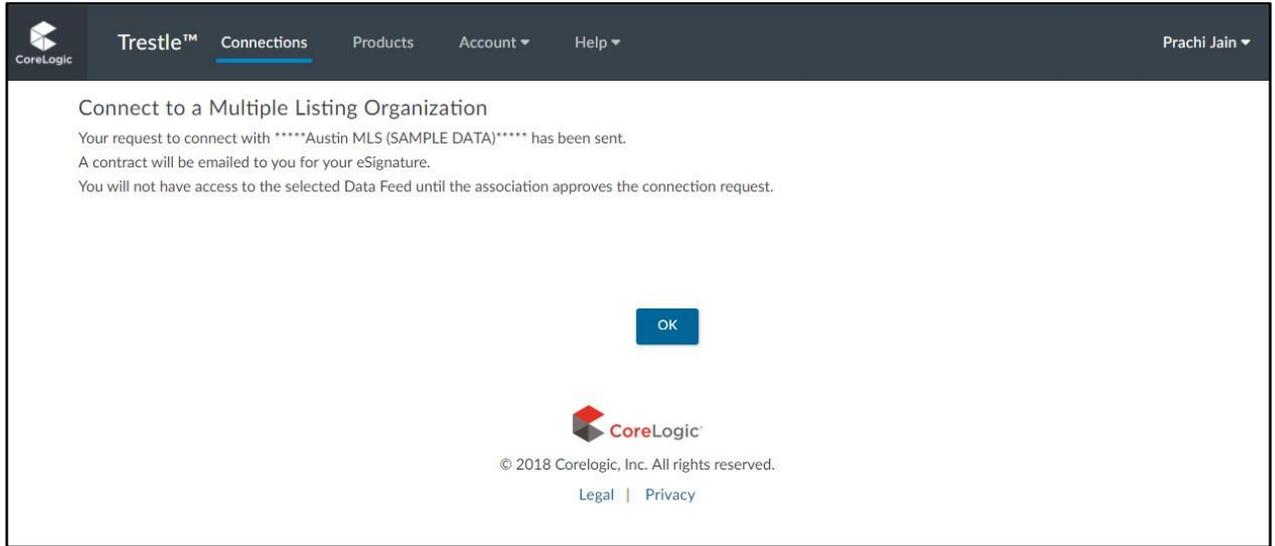
1.7 “Trestle” means CoreLogic’s platform that aggregates multiple listing data and facilitates access and distribution of the Listing Data.

2. OWNERSHIP

Technology Provider acknowledges that ownership and use rights relating to copyrights in the Listing Data are defined in the Policies. Technology Provider shall not challenge or take any action inconsistent with Multiple Listing

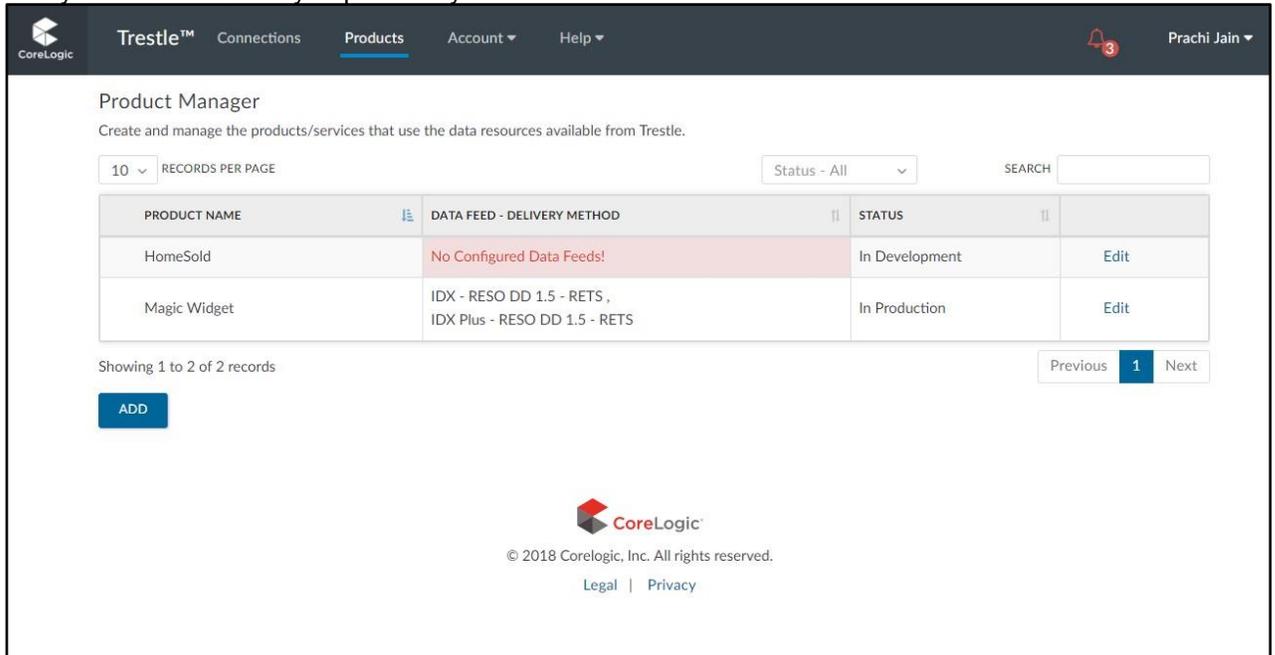

Once you click Connect, your request will be sent to the MLO and a contract will be emailed to you for eSignature.



- These simple steps enable to you initiate a RETS data feed Connection with a Multiple Listing Organization with speed and assurance.

Connect with a multiple listing organization. Click **Edit** to modify the product and **Add** an associated Data Feed.

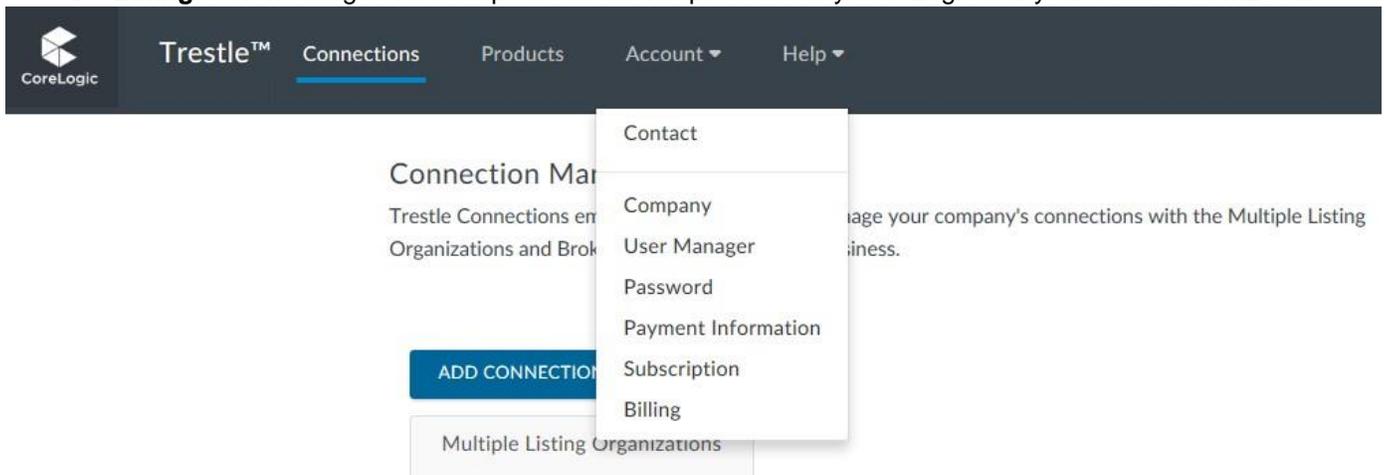
Please also note that a Multiple Listing Organization may not choose to support a Data Feed for which your product is configured. You are welcome to add as many Data Feeds as you wish to your product, but please recognize that is your responsibility to manage use of multiple Data Feeds through your implementation. Trestle enables you to **Delete** a Product that is no longer relevant, provided it has no associated Data Feed or active Connection.

Account Manager

Some account information is furnished during the subscription process. The Account Manager enables you to control that and other information about your organization that is vital for the operation of Trestle. Specifically, you can manage:

- **Contact** for the individual managing Trestle on behalf of your organization.
- **Company** conveys information about your company to Multiple Listing Organizations and Brokers who may wish to connect via Trestle.
- **User Manager** allows the individual managing Trestle to create additional users for their Trestle account. Hence, allowing multiple members to have access to the TP's Trestle account.
- **Password** to change or update your Trestle credentials.
- **Payment Information** manages credit card data for fees that are payable to CoreLogic for use of Trestle or to Multiple Listing Organizations for data access.
- **Subscription** to review the Trestle subscription agreement. □
- **Billing** to view charges via receipt or statements processed by CoreLogic and your connected MLOs □

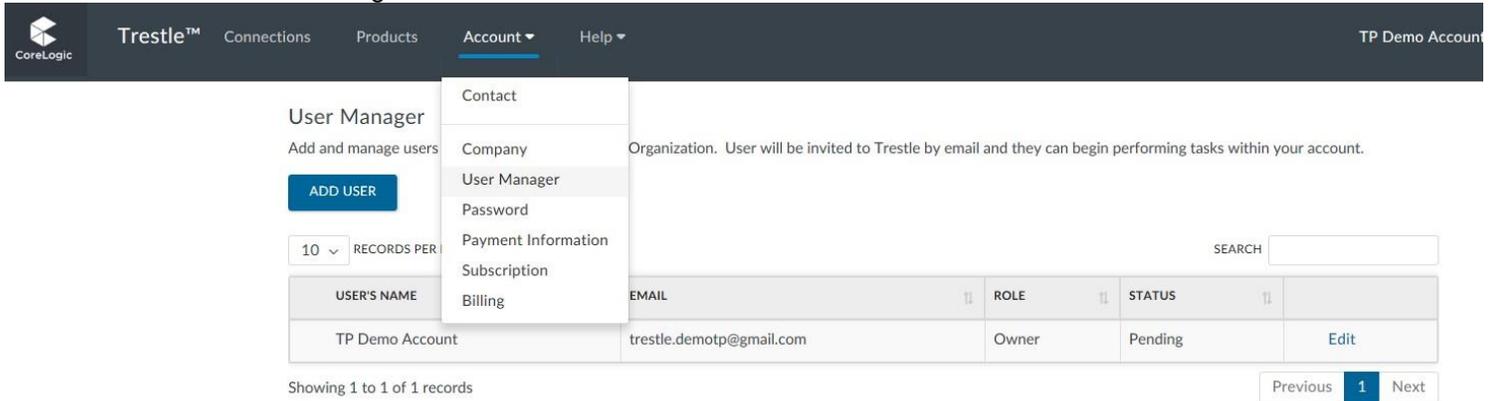

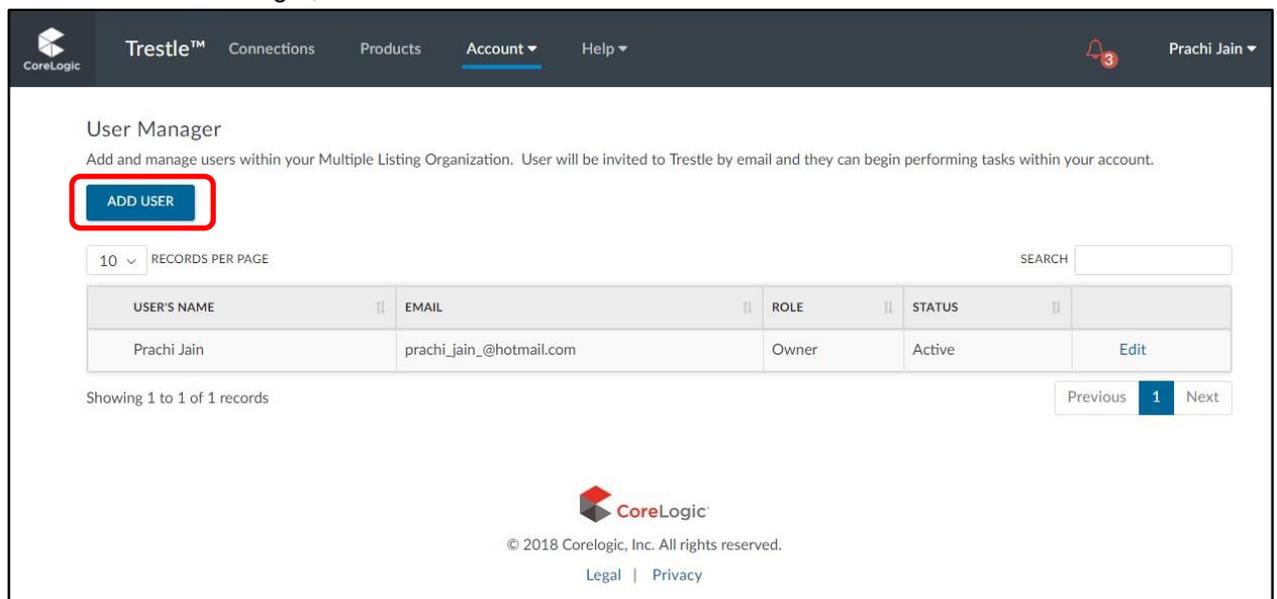

Transport Mechanisms

Two transport APIs enable solutions to connect, request, and consume data feeds. The mechanisms are:

- The WebAPI, a RESTful API based on the Real Estate Standards Organization's (RESO) WebAPI 1.7 specification and OData 4.0□
- The RESO Real Estate Transaction Standard (RETS) API, an older API based on the RESO RETS 1.8 specification.□

Both transport mechanisms return data based upon RESO Data Dictionary 1.5 schema specification at the time of this publication. Support for 2.0 and future versions will be included as the standards evolve, and new versions are ratified by RESO.

Rather than provide extensive documentation for these standards directly herein, Technology Providers are encouraged to review the documentation directly on the RESO site; a great deal of time and care has gone into the creation of these standards, and the support information regarding their purpose and use is best viewed at the source.

Search requests are made via the OData **\$filter** parameter. \$filter queries use the syntax described in section 11.2.5.1.1 of the OData specification, along with [examples](#).

To initiate a search request:

1. Make a GET request to [https://api-trestle.corelogic.com/trestle/odata/\[model name\]?\\$filter=\[query\]](https://api-trestle.corelogic.com/trestle/odata/[model name]?$filter=[query]) The [model name] should be replaced with a model exposed in the service model, and [query] replaced with a valid \$filter query.
2. The response will be a JSON object Notes:
 - No **string functions** are currently implemented.
 - The additional system query options currently available are **\$top**, **\$count**, and **\$select**.

Basic Search Arguments

SearchType=Property

This designates the Resource to search and for this example the Property resource is desired.

&Class=PROPERTY

This designates the Class to search and in this example Property is the only Class in the Property Resource

&QueryType=DMQL 2

This designates the RETS query language as DMQL2 and is the advised query language from the standard

&Limit=20

This designates the maximum number of records to return to the client for the request

&Format=COMPACT

This designates that the client wants records returned using the COMPACT data format. This is the advised format to use.

&Query=(ModificationTimestamp=2016-01-01%2B),(Mls Status=Expired),(ListPrice=200000-300000)

The Query argument designates the search criteria to use for the request. The following covers how to use fields of different types and logical operations using the DMQL2 query language.

Query Fields by Data Type

Integer

For fields that represent an Integer value such List Price below, the number must be non- negative and have no decimal points.

(ListPrice=200000),

Integers may also be searched using less than, greater than, and range values as follows below.

(ListPrice=300000-), (ListPrice=200000+), (ListPrice=200000-300000),

Please note that the '+' symbol must be URL encoded as '%2b' or it will not be recognized.

Decimal

For fields which represent a Decimal value such as Lot Size Acres below, the number must be non-negative and only have as many decimal points as the field Precision in the metadata. For the following example the Precision is 3.

(LotSizeAcres=0.171),

Decimal value may also be searched using less than, greater than, and range values as follows below.

(LotSizeAcres=0.201-), (LotSizeAcres=0.101+), (LotSizeAcres=0.101-0.201),

Please note that the '+' symbol must be URL encoded as '%2b' or it will not be recognized.

Date Time

For fields that represent a Date and Time value the format is represented as YYYY-MM-DDTHH:MM:SS where the 'T' is literal.

Boolean

For fields that represent a boolean True or False value, the format is represented as Y or N in the criteria.

Lookup

For fields that represent a single value selected out of a set of possible values, a Lookup, the value used must match one of the possible values from the field metadata.

(MlsStatus=Expired)

Multiple Selection Lookup

For fields that represent one or more values selected from a set of possible values, a Lookup- Multi, the value or values used must match one of the possible values from the field metadata. (PoolFeatures=|P,Q)

Query Logical Operations

To combine two criteria together into a single query statement, use the AND operator. This may be represented as 'AND' or ',' in the query string as follows.

(ModificationTimestamp=2016-01-01%2B),(MlsStatus=Expired) (ModificationTimestamp=2016-0101%2B)AND(MlsStatus=Expired)

To separate two criteria into separate statements, use the OR operator. This may be represented as 'OR' or '|' in the query string as follows.

(GarageYN=Y)OR(PoolFeatures=|P,Q) (GarageYN=Y)|(PoolFeatures=|P,Q)

To exclude specific criteria values, use the NOT operator. This may be represented as 'NOT' or '~' in the query string as follows. NOT(MlsStatus=Expired)

~(MlsStatus=Expired)

Query statements can be grouped as needed using parentheses as follows.

NOT(MlsStatus=Expired) AND ((ModificationTimestamp=2016-01-01%2B) AND ((GarageYN=Y)OR(PoolFeatures=|P,Q)))

- **IDX Plus** – Supports the latest RESO Data Dictionary standard of On Market data and up to 7 years of Off-Market data (Active, Pending, Active w/Contract, and Sold statuses (and the selling information that goes with the sold status, like Close Date, Selling Agent, Selling Co-Agent and Selling Office)
- **VOW** – All status /MLS data (on market, up to 7 years of off market, expired, withdrawn)
- **Back Office for Technology Providers** - Back Office Feed for Technology Providers to manage on behalf of a Broker(s)
- **Broker Data Feed** - The aggregated feed for Brokers. Includes the brokerage's on and off-market data, plus roster. Compliant with NAR Participant Data Access policy
- **Statistics** - At the discretion of the MLS, updated to have all fields (active, pending, sold, withdrawn, expired...) this feed does not have photos
- **Roster Only** - Membership ONLY data (Office and Agent data)
- **Sample Data feed** - MLOs Sold/Closed listing from 2016, with 1-stock photo
- **Matrix RETS**
- **Trestle Direct Web API to Matrix**

Please note that the IDX, IDX Plus and VOW Data Feeds are provided for purposes of RESO certification; one for the Data Dictionary and one for Web API certification.
